This can also be observed in the results of a social survey on "Women of Uzbekistan-2015: Social Status and Social Mood," conducted in 2015 by the "Ijtimoiy Fikr" Center for Public Opinion Research, regarding the state of society's socio-spiritual environment. For instance, 94.3 percent of respondents felt socially and legally protected from violations of their rights and freedoms in education, employment, entrepreneurship, access to medical services, and

participation in socio-political life. While 93.1 percent of the study participants believe that women's role in raising a harmoniously developed generation has increased in recent years, 84.4 percent think that individuals with a sensitive nature are more involved in creating a positive atmosphere in the family. Additionally, 78.7 percent stated that women frequently make important decisions and contribute significantly to the family budget. 86.1% of women in the country expressed satisfaction with their lives.

3. Despite the implementation of such reforms in our country, crime rates among women are increasing. We can attribute this to the following reasons:

4. Economic factors. Unemployment and the inability to find solutions to family financial problems can lead to crime. It is known that this seems an easy way out, but some people may draw negative conclusions about the system when their problems are not resolved after approaching the relevant authorities once or twice. In their view, the laws are ineffective, and the state does not care about the people.

Social factors. Due to lack of knowledge, disrupting family life and ignorance of household chores lead to family conflicts. The intolerance of in-laws to these issues results in an increase in suicide cases among women due to an early loss of interest in life. Informational factors. Today, all family issues and problems are being shared on social networks, spreading and promoting this content among the masses, which shapes aggressive attitudes in others. Medical factors. The lack of proper marital relationships in the family leads to psychological trauma in women, resulting in a loss of desire to live within the family and a diminished will to live in general, which contributes to criminal behavior.

Ignorance. This word refers to people who do not read books, do not follow what they read, and blindly imitate what they see and hear everywhere. The ignorant is ruthless - savage, oppressive; they are unkind, indifferent, and irresponsible. One type of ignorance is a selfish person who approves only of his own opinion and considers others stupid. The increase in such people is one of the reasons for family unrest. After all, both children and women should be listened to and respected in the family. The injustice of an ignorant husband leads some women and children to crime. That's probably why there's a rumor about the woman who killed her husband. A child raising their father is being analyzed. Is this woman and child a criminal, a sinner, or a victim? Educational factor. The lack of paternal upbringing and military education for children in the family. In this case, the father's role in the family, the increase in divorces in recent years

resulting in children remaining in their mother's care while the father continues his life with another woman, leads to women committing crimes or attempting suicide to feed their children. In fact, paternal upbringing is insufficient due to a lack of religious understanding that the child is the father's descendant, and because of avoiding responsibility. It is necessary to establish strict liability in legal norms to increase fathers' responsibility. Furthermore, today, every adult son should be obligated to serve in the military to fulfill his duty to the Motherland.
